
No. PPA 0206/CR-57/SPL-6.- In exercise of the powers conferred by sub-sections (1), (2) and (3) of section 13 of the Immoral Traffic (Prevention) Act, 1956 (1104 of 1956) and in supersession of government Notification, Home Department, No. PPA-1191/1/POL-8, dated the 20th July 1992, the Government of Maharashtra hereby,-

- (a) appoints the police officers specified in column (1) of the Schedule hereto to be the Special Police Officers for the areas, respectively specified against each of them in column (2) of the said Schedule, for dealing with offences under the said Act, in those areas, and
- (b) Directs that the Special Police Officers so appointed shall be assisted by the subordinate police officers, respectively specified against them in column (3) of the said Schedule,





IMMORAL TRAFFIC (PREVENTION) ACT, 1956.

No. PPA. 0611/C.R. 432/SPL-6.—In exercise of the powers conferred by sub-sections (1), (2) and (3) of section 13 of the Immoral Traffic (Prevention) Act, 1956 (104 of 1956) and of all other powers enabling it in this behalf, the Government of Maharashtra hereby amends the Government Notification, Home Department, No. PPA. 0206/C.R. 57/SPL-6, dated the 14th March 2006 (hereinafter referred to as "the said notification") as follows, namely:—

(1) In SCHEDULE I appended to the said notification, after entry 6, the following entry shall be inserted, namely:—
